Waste Disposal Service Account Agreement Terms and Condition (Revised September 20, 2021)

- 1. Prior to using the waste disposal services (discharging into the Seeley County Water District ("SCWD") wastewater treatment plant facility) a manifest must be completed for each discharge load showing the discharging company name, company driver signature, source of the load, vehicle's total load capacity and/or, if metered, actual volume of load.
- 2. Disclose any chemical usage that may be present within the load and provide with the manifest any Material Safety Data Sheets (MSDS) associated with the chemical usage.
- 3. The Company/Owner shall conform to the existing Sewer Use Ordinance and understands that any violation shall be just cause to revoke permission to use this facility. Company/Owner shall thereafter be prohibited from any further use of waste disposal services. Violation of these conditions may subject Company/Owner to additional penalties and/or fines as authorized by State or Federal Law.
- 4. Company/Owner agrees to indemnify, defend, and save SCWD and its agents and employees harmless from any and all liability, claims, damages, or injuries to any person, including injury to SCWD employees and claims which arise from or are connected with the Company/Owner's discharge of waste disposal or performance of or the failure to perform the work or other obligations of this agreement, or are caused or claimed to be caused by the acts or omissions of, Company/Owner its agents or employees, and all expenses of investigating and defending against same; provided, however, that this indemnification and hold harmless shall not include any claim arising from the sole negligence or willful misconduct of the SCWD, its agents or employees.
- 5. With the exception of holidays waste disposal services at the SCWD wastewater treatment plant facility are available from 1:00 pm to 3:30 pm, Monday, Wednesday, and Friday. Hours are subject to change at the discretion of the SCWD wastewater treatment plant Operations Supervisor or Designee.
- 6. Current rate is \$0.26 per gallon; with a monthly recurring administrative fee of \$50.00. All users will be charged as full loads according to vehicle's total gallon capacity registered in Waste Disposal Service Agreement (terms and conditions). The per gallon rate is subject to revision at the discretion of the SCWD Board of Directors and SCWD Administrative General Manager and Secretary of Board. SCWD will bill once per month, late accounts will be subject to a \$75.00 late fee and accounts paid after 30-days are delinquent and are subject to a 1.5 percent penalty fee on any remaining unpaid balance. If the remaining unpaid balance remains unpaid by the next billing cycle, SCWD will discontinue services; account should become current, and customer will have to re-establish credit; at which time you will not be allowed to dump until the total balance is paid in full.

7. Company/Owner agrees to carry liability insurance on tankers with the amount of \$1,000,000.00 combined single limit for any injury to person and/or damage to property. It is also required to name the Seeley County Water District as an additional named insured.

SAMPLING & DISPOSAL PROCEDURES

Each vehicle must be equipped in such a manner that a "grab" sample can be taken. A wastewater plant operator shall collect a representative sample of each delivery prior to allowing driver to discharge.

If, in the opinion of the wastewater plant operator, the waste appears to be of a source other than septic tank or portable toilet waste, the hauler may be denied discharge and instructed to exit the facility. SCWD reserves the right to deny any and all loads at its discretion.

Sampling/testing shall be conducted for the following constituents.

***pH** / **temperature** - Hauled waste must have a pH level between 6-9.

Cyanide and Copper: Samples will be collected for laboratory analysis and results will be used at SCWD discretion to deny loads from dischargers with repeat loads containing Cyanide and/or Copper.

SCWD may refuse to accept any hauled wastewater if it is deemed unsatisfactory for discharge at the Wastewater Treatment Plant.

All haulers are to keep the unloading facility clean and neat. Any spillage is to be immediately reported to the Wastewater Plant Operator, and the area cleaned and sanitized.
